This was an email I hoped I'd never have to write.

**Your National Association for Gun Rights is officially calling for Attorney General Pam Bondi to be FIRED.**

Those are not words that we take lightly - but Pam Bondi has given us no choice.

While we all had major concerns with the nomination of Pam Bondi as Attorney General, we hoped for the best and that she would prove a staunch advocate for the right to keep and bear arms.

Unfortunately, it's been NINE MONTHS since Bondi was confirmed, and it has become increasingly evident that she has failed the Second Amendment.

The straw that broke the camel's back came this week, when she **convinced a federal judge to demand the member lists of TWO national Second Amendment advocacy organizations.**

**That's right - Pam Bondi's DOJ successfully scored a court order for two gun groups to HAND OVER THEIR MEMBERS' PRIVATE INFORMATION to the federal government; names, addresses, contact info - everything.**

Enough is enough.

Gun owners deserve an Attorney General who will FIGHT for the Second Amendment; not treat it as a second-class right. It's time for Pam Bondi to go.

**Stop what you're doing.**

**Right now, before you do anything else, I'm calling on EVERY SINGLE MEMBER of the National Association for Gun Rights to sign your petition calling for the immediate termination of Pam Bondi as Attorney General.**

*You thought we were done with this nonsense when Biden left office, didn't you?!*

**Over the past eight months, Attorney General Pam Bondi has MAJORLY betrayed law-abiding gun owners across America time and time again.**

**\*\*\* Exhibit A: Bondi's DOJ still upholds Biden's "engaged in the business" ATF gun control rule:** Rather than repealing the Biden-era "engaged in the business" ATF rule that gave the ATF a blank check to crack down on private firearm sales, Bondi's DOJ has "reviewed" the rule for months while still enforcing it against gun owners. Meanwhile, her DOJ repeatedly asks the courts to delay the legal challenges that could bring relief for gun owners.

**\*\*\* Exhibit B: Bondi's DOJ is advocating for LIFETIME GUN BANS for nonviolent offenses.** Bondi's DOJ asked the Supreme Court NOT to restore the rights of nonviolent felons (*Vincent v. Bondi*), and instead advocated for federal law to continue stripping gun rights from nonviolent offenders FOR LIFE.

**\*\*\* Exhibit C: Bondi's DOJ has repeatedly supported BANNING GUNS from military-aged adults.** Bondi's DOJ is actively attempting to undermine the 5th Circuit's pro-gun ruling in *McCoy v. ATF*, which held that the federal ban on handgun sales to 18-20-year olds is unconstitutional. Meanwhile, her DOJ asked the Supreme Court NOT to overturn the 4th Circuit's ruling upholding that very same gun control law. She's publicly endorsed stripping gun rights from American adults who are old enough to fight and die for our country!

And now we have the most egregious of them all; **directly attacking national gun rights organizations by demanding their private membership lists.**

In that very same lawsuit challenging handgun purchase rights for 18-20-year-olds, *McCoy v. ATF*, Bondi's DOJ argued for a two-tiered classification of gun owners - those who belong to the plaintiff gun rights organizations, and those who don't.

Then, Bondi's DOJ argued that they had to know who the members of those gun rights organizations were so the DOJ could be sure to protect THEIR rights - and only their rights.

This is a clear violation of the First Amendment right to freely associate - and to do so anonymously.

But Bondi's DOJ thinks gun owners should have to choose between their First Amendment rights and their Second Amendment rights - and they told the court just that:

except for the three individual plaintiffs. To be sure, the organizational members may have a First Amendment right to decline to disclose the identity of their members to Defendants. *See, e.g., NAACP v. Alabama ex rel. Patterson*, 357 U.S. 449, 466 (1958). But the organizational plaintiffs cannot have it both ways. The organizational plaintiffs cannot simultaneously decline to identify any of their members and at the same time insist that the Court award permanent relief to unidentified persons whose membership has not been verified.

That reads like a Biden-era goon wrote it - but no.

That came from Pam Bondi's DOJ.

To be fair, Bondi's DOJ has done some good things for the Second Amendment as well - but those things are increasingly dwarfed by the ongoing and active harms this DOJ continues to perpetuate against gun rights.

The absolute baseline rule for a pro-gun attorney general should be to FIRST DO NO HARM to gun rights - and in Pam Bondi's case not only has her DOJ continued Biden-era gun controls, but is actively working behind the scenes against gun rights.

**That's why now is the time to bring the hammer down on Pam Bondi for her relentless anti gun actions that betray the people she swore to protect!**
